## Randolph Recreation Financial Assistance Form Summer 2026

### WHO IS ELIGIBLE?

Randolph recreation participants experiencing financial difficulty or facing unique hardship situations are eligible to apply for assistance. It is understood that from time to time, families may encounter some unforeseen and unfortunate circumstances. During these times, financial assistance may be needed to help a family meet some recreational needs. If you feel you need assistance but do not meet the income guidelines, you may attach a letter to your application stating your circumstances. These are special circumstances and will be handled on a case-by-case basis.

The Randolph Financial Assistance program is funded by donations and grants. This fund is not supported by tax revenue. Financial Assistance is available on a first-come, first-serve basis and dependent on available funding.

### HOW TO APPLY?

In order to be considered for financial assistance, you must complete and submit the 2026 recreation programming registration forms for your children through [RandolphVT.MyRec.com](http://RandolphVT.MyRec.com) **and** complete this financial assistance form and submit it to the email address above or drop it off at the Recreation Dept. at the Town Office **by June 19, 2026**, late financial assistance requests will only be considered if funding remains available.

**HOW DOES THE ASSISTANCE PROGRAM WORK?**

Dependent on available funding, financial aid awards will be 30% or 50% based on the income guidelines listed below for the 2026 Summer Recreation season.

The remaining balance shall be paid by the applicant. Financial assistance applications will continue to be accepted until available scholarship funding is exhausted for the year. Financial Assistance will be awarded on a first-come, first-served basis while funding is available. If you feel you need assistance but do not meet the income guidelines, you may attach a letter to your application stating your circumstances. These are special circumstances and will be handled on a case-by-case basis.

We strive to review applications and respond within one week of the financial assistance application being submitted. All financial information will be kept confidential, and documents disposed of appropriately after the 2026 recreation season.
